# From the BOARD & CEO

#### Dear Friends,

From its creation in 1965 as the Portsmouth Community Trust, the Southeast Virginia Community Foundation successfully completed its 56th year in 2021 by fulfilling our mission of connecting donors to causes that matter. In celebrating this success, we are very pleased to present the Annual Report for the year ending 2021. Even during the continued challenges of the pandemic, the Foundation's assets grew through the generous donation and partnerships we share with many donors, non-profits, and the community at large.

The Foundation added five new Donor Advised Funds (DAF) totaling \$293k. Contributions to existing DAF's added an additional \$254k. The Foundation also established two new Scholarship Funds. We are pleased to report over \$597k in contributions in 2021. With the increase in donations and a favorable return on investments, the value of our net assets grew to \$18,804,658, and we experienced a combined 12.5% growth in investments in our portfolio. Furthermore, the Match program, for participating non-profit organizations, continues to perform very well; growing from \$210,523 in 2015 to \$2,429,331 in 2021. Also in 2021, we awarded 131 grants and 41 scholarships totaling \$575,295.

Other events of the Foundation included the departure of Stephen Best, who served the Foundation admirably in his five years as the CEO. During his tenure, much of the Foundation's success can be attributed to "Chief" Best and his relationship with the Chesapeake community, and the creation of the Match Program with TowneBank. Mr. Best will continue his leadership in philanthropy succeeding Judge Richard Bray as the President and CEO of the Beazley Foundation in Portsmouth. In April, we wished Mr. Best much success in his future and welcomed Richard Wentz as our new

CEO. Richard was the former Executive Director at the Portsmouth YMCA and longtime member of the SEVACF Board of Directors. Additionally, we welcomed Amy Folkes as our new President.

This year can be considered a success for the Foundation, and the coming years bring with it both challenges and opportunities. We are grateful for our accomplishments in serving the community and connecting donors to causes that matter.

We thank you for your dedication to this community and look forward to the journey ahead.



# Al Taylor's Good Name and Works Live on Through a SEVACF Scholarship Fund

Al Taylor was a real legend in the Portsmouth area, an attorney and volunteer who gave so much of his talents to better the community.

He got started early, catching and selling soft shells along the James River in Newport News where he grew up. Neighbors turned to Al to cut lawns, paint houses and handle other odd jobs.

For a career, he set his sights on the law. After graduating with a history degree from Belmont Abbey College, Al enrolled at the Marshall Wythe School of Law at the College of William & Mary. To afford it, he once held down three jobs. Armed with his JD, Al received an appointment to the Office of the Chief Counsel for the Internal Revenue Service where he worked for four years before moving to Portsmouth and entering private

practice with Cooper, Spong and Davis and later Williams Mullen.

Al displayed tremendous dedication over the next 45 years, going the extra mile for clients and consistently earning listings in Best Lawyers of America, Virginia Super Lawyers, and Legal Elite.

For his efforts on behalf of numerous community

and business organizations on whose boards he served (including SEVACF and the Portsmouth Foundation for two decades), Al was named First Citizen of Portsmouth in 2008. Al, who passed away in 2016 at the age of 73, left behind his wife Fran of 46 years, two daughters and four granddaughters.

After Al Taylor's death, admirers and friends began a fund in his honor with SEVACF. It today provides two \$7,500 college scholarships a year for deserving local students. What an inspiration Al Taylor was to his profession and his family and now his name lives on through this fund.

# SEVACF Fulfills \$50,000 Pledge to Help Construct Battle of Great Bridge Museum

It's not nearly as well known as the Battle of Bunker Hill in Massachusetts, but the victory by American rebels over British troops on December 9, 1775, also had a consequential impact on the Revolutionary War.


It was the very early days of the conflict, and British Royal Governor of Virginia Lord Dunmore built a fort on the north side of the river to control the Great Bridge, about eight miles from downtown Norfolk. Controlling that area was vital to maintaining supply lines and protected the only land route to Norfolk, so both sides brought troops there, the colonial army fortified with a number of men from North Carolina. To break up the Patriot gathering, Dunmore ordered an attack across the bridge, which was decisively repulsed with more than a hundred British personnel killed or injured and only one of the colonists wounded.

Dunmore and his Tory allies withdrew to navy ships in the harbor, and Norfolk was subsequently occupied by Patriot forces by mid-December. On New Year's Day 1776, the Americans destroyed the city.

In 2017, the Great Bridge Battlefield & Waterways History Foundation requested \$50,000 from SEVACF to help construct a museum. Now complete, the attraction is bringing visitors to learn about the first victory by the patriots during the Revolution. "We are so grateful to the Southeast Virginia Community Foundation for their support," says Foundation Director Elizabeth Goodwin, "and we invite anyone from throughout Hampton Roads to come enjoy this peaceful and beautiful space and cherish an important chapter in our nation's history." SEVACF provides tailored services to help individuals, families, businesses, and other groups pursue their charitable goals easily, effectively, and with maximum tax benefit.

Through our two competitive grant cycles each year, SEVACF supports southeast Virginia's most exciting and urgent charitable projects. We serve as a catalyst, leading collaborative solutions to key community issues as they arise.

SEVACF also manages designated endowments on behalf of nonprofits through The Match program, providing these groups with sustainable, easy funds for whatever their needs may be while promoting financial stability.

Through our scholarship program, SEVACF has helped many local students pursue their dream of a college education. We have awarded both need-based and merit-based scholarships to the future leaders of our country.
